ACTIVITIES COMMON TO THE TWO REGIONS WITHIN THE
ORGANIZATION'S GENERAL PROGRAMME OF WORK FOR 1992-1993
Agenda item 4 (document CAP/CSA/9/1)

The Commissions,

Having considered the document submitted by the Secretary-General on this Agenda item,

Having listened to the Members' views on the subject,

I. With regard to education and training

1. Realize the need for continued efforts in the direction of training the trainers on a long term basis;
2. Call upon the Members to compile inventories of training facilities available in their respective countries and their training requirements in various fields and forward them to the Secretariat as early as possible;
3. Appreciate the offer of the Secretariat to act as a clearing-house for compiling and classifying the information before circulation to various countries;
4. Accept with gratitude India's offer to accommodate candidates from the Asian countries in the regular training programmes being organized by the Indian Institute of Tourism and Travel Management;
5. Urge the Members to establish contact with the International Hotels Association with a view to securing donations of used training equipment from the reputed hotel chains;
6. Request the Secretariat to compile information on the activities carried out by various international organizations for development of human resources in the tourism sector and circulate it to the Members;

7. Decide to prepare a detailed Action Programme for systematic development of tourism training in Asia; and
8. Welcome the offer of the representative of the UN Economic and Social Commission for Asia and the Pacific (ESCAP) to extend technical assistance to the countries under its Technical Cooperation Among Developing Countries (TCDC) programme.

II. With regard to marketing and promotion

1. Recognize the importance of regular exchange of statistical information between the Members;
2. Request the Members to provide information such as statistics, annual plans, studies, and annual reports to the Secretariat on a regular basis; and
3. Appreciate the Secretariat's offer to undertake institutional arrangements necessary for coordinating the collation and distribution of information to the Members.

III. With regard to environment and planning

1. Recognize that sustainable development is the key to orderly and planned development of tourism;
2. Call upon the Members to devise a system whereby information on environmental impact assessment is regularly exchanged between the national tourism administrations; and
3. Urge the Members to organize familiarization tours for personnel of national tourism administrations in the region and those involved in the planning process in order to provide them with a firsthand knowledge of both positive and negative developments.
