TECHNICAL COOPERATION

Agenda item 4(a) (document CAM/18/4(a))

The Commission,

Having regard to the importance of technical cooperation for the economic and social development of the developing countries,

Considering that the aims of the Organization, as set forth in article $\overline{3}$ of the Statutes, provide that the Organization "shall take all appropriate action to attain this objective",

Considering that paragraph 2 of the Statutes also provides, with respect to the same objective, that "the Organization shall pay particular attention to the interests of the developing countries in the field of tourism",

Considering that technical cooperation, with preference given to the developing countries, is one of the priority fields of activity of the programme of work of the Organization, as approved by the General Assembly at its seventh session,

Considering that mechanisms to achieve the aims of the Organization must be provided, and

Considering that the current financial regulations make it difficult to attain these aims and fulfil the mandate issued by the General Assembly,

Recommends the General Assembly to delete paragraph 6 of Article 4 of the Financial Regulations of the Organization approved at its first session at Madrid on 23 May 1975.

EDUCATION AND TRAINING

The Commission,

Having taken cognizance of the communication of the Secretary-General concerning the implementation of the general programme of work for 1988-1989 in the field of tourism education and training,

Having regard to the need to correct the imbalances that occasionally exist between the supply and demand of tourism and hotel personnel in the various American countries, and

Taking into account the need to avoid duplication of effort in advanced tourism training in the countries of the region,

- 1. Commends the Secretary-General for the innovative approaches the Secretariat is taking to tourism training and education mechanisms;
- 2. Emphasizes the increasing importance of tourism education and training for the development of tourism in the Americas;
- 3. Receives with interest the information provided by the Secretary-General concerning the signing of an Agreement with Simon Bolivar University of Venezuela, for the establishment of a regional tourism training centre;
- 4. Takes note with interest of the preliminary proposal by Puerto Rico to establish, with the support of the United States Agency for International Development and the Caribbean Hotel Association, a training centre for tourism personnel in Puerto Rico;
- 5. Requests the Secretariat to set up a mechanism for the exchange of tourism personnel and experts between the various countries of the Americas region; and
- 6. <u>Urges</u> the member countries to study training needs in cooperation with the advanced tourism training institutes and to increase the degree of specialization in each tourism training centre.

Having regard to the need to strengthen tourism relations within the Americas region, as well as between the public and private sectors,

- 1. Expresses its satisfaction with the follow-up by the Secretariat on the recommendations of the two Workshops that have been conducted on this subject in the Americas region;
- 2. Receives with interest the proposal to conduct bi- or tri-national seminars in which tourism administration, private tourism enterprises in the countries concerned and specialized tour operators in the main generating markets would take part, with a view to generating concrete proposals for itineraries that could be marketed in the short term;
- Receives with interest the offer of cooperation made by the Affiliate Member COTAL to help improve the effectiveness of work by national tourism administrations in promoting integrated itineraries;
- 4. Requests the Secretary-General to study with COTAL the ways in which this confederation would be willing to cooperate with WTO in this field;
- 5. Decides to include in the agenda of the special meeting of the Commission devoted to the preparation of the Fifth Centenary of the Discovery of the Americas (Santo Domingo, Dominican Republic, 12 and 13 October 1988), the study of itineraries related to this event; and

- Commends the Secretariat for the initiatives it has taken in this field;
- 2. <u>Urges</u> the Members of the Commission to support the efforts of the Secretariat to achieve a lasting peace in this region; and
- 3. Expresses the wish that the proposals prepared by the Secretariat will be finally approved by UNDP.

The Commission,

Having been informed of the arrears in the payment of contributions from certain Members of the Americas region to the budget of the Organization,

- 1. Urges these Members, in pursuance of decision 4(XXXIII), adopted by the Executive Council at its thirty-third session (Madrid, May 1988), to fulfill their financial obligations so that the implementation of the general programme of work on behalf of all Members of the Organization will not be affected;
- Invites the officers of the Commission to approach Members that have still not paid their contributions to do so as soon as possible; and
- 3. Appeals to its representatives (Colombia, Mexico, Puerto Rico and the United States) in the Working Party set up by the Executive Council to study the formula for fixing the contributions of member States to consider a new formula reflecting more equitably the level of tourism income in each country.

FOLLOW-UP TO THE INVITATION OF THE GOVERNMENT OF THE DOMINICAN REPUBLIC TO CELEBRATE A SPECIAL MEETING OF THE COMMISSION DEVOTED TO THE PREPARATION OF THE FIFTH CENTENARY OF THE DISCOVERY OF THE AMERICAS

Agenda item 9 (document CAM/18/9)

The Commission,

Taking into account that the peoples of the Americas should reafirm their loyalty to their cultural roots and identify themselves with the historical meaning of the Fifth Centenary of the Discovery of the Americas,

Having regard to the efforts made in each country of the continent to ensure a worthy celebration of this momentous occasion,

Considering that it would be opportune for the Americas countries to combine efforts and plans that can be transformed into viable collective projects to promote the celebration of the Fifth Centenary,

Having heard the presentation of the delegation of the Dominican Republic, confirming the invitation it extended during the thirty-first session of the Executive Council to serve as host of the special meeting of the CAM, at Santo Domingo on 12 and 13 October 1988, to consider possibilities for joint activities among the American countries in the celebration of the Fifth Centenary, and

Having seen the communication CAM/18/9 of the Secretariat concerning the follow-up given to the invitation of the Dominican Government,

- 1. Supports, in the spirit of solidarity, the proposal of the Dominican Government to hold a meeting of the Ministries and international tourism organizations of the American continent to seek agreements on collective activities that the nations of America can undertake better to observe the Fifth Centenary of the Discovery of the Americas;
- Urges the governments of the member countries of the CAM to commit their support and assistance to the aforementioned special meeting;
- 3. Expresses its desire for the Secretariat of WTO to offer the greatest possible cooperation to the official tourism administration of the Dominican Republic so as to have the best possible organization of this special meeting;
- 4. Commends the Government of the Dominican Republic for the initiative it has taken in this regard, which, in the judgement of the Commission, addresses the latent concerns and desires of all the nations of the continent with respect to the Fifth Centenary; and
- 5. <u>Invites</u> the member countries to send to the Secretariat their proposed themes to be included in the agenda of this meeting, as well as suggestions concerning the international bodies that could be invited to take part in this meeting and support the activities resulting from the decisions of that meeting.

Having taken cognizance of the communication of the representative of the Organization of American States agreeing with the Secretary-General on the need for closer cooperation between the two organizations and indicating the willingness of OAS in this regard,

- 1. Commends the Secretary-General for his initiative of reactivating institutional contacts with OAS, particularly in times of financial restrictions;
- 2. Reiterates the need to avoid the duplication of work between these organizations in the field of tourism in the Americas region; and
- 3. Expresses its desire to obtain the financial support of the Organization of American States for the activities of the World Tourism Organization in the Americas region.

Having taken note of the communication of the Secretary-General concerning the tasks performed by the Organization with regard to the multilateral negotiations to liberalize international trade in services, including tourism,

Aware of the repercussions that the inclusion of tourism in such negotiations, especially those currently being conducted within GATT, could have on the development of the tourism sector, and

Taking into account the complexity of the mechanisms that may affect such multilateral negotiations concerning tourism services and the still incomplete knowledge of the role of tourism in the process of national development and international trade,

- 1. Expresses its desire to obtain greater documentation and information on the subject before taking any decision that may affect the development and operation of the tourism sector; and
- 2. Decides to consider the creation of a study group on tourism and international trade in services during the preparatory meeting for the expanded Facilitation Committee that the American countries will hold on 30 September and 1 October 1988 at Madrid.
