### Auditors' travel expenses and subsistence allowance

Agenda item 2

The Executive Council,

Considering the voluntary and disinterested contribution made by the Auditors to the work of the Organization for the benefit of its Members,

<u>Decides</u> that their travel and living expenses during the time spent by them at Headquarters to audit the accounts will be refunded by the Organization according to the existing schedules.

### Dates of the beginning and end of the terms of office of the Council Members

Agenda item 3

The Executive Council,

Recalling the decision taken at its second session that the terms of office of its Members shall begin on the first of January following their election and end on the thirty-first of December of the final year of their term of office,

#### Decides:

- (1) to include this provision in its Rules of Procedure;
- (2) to allow new Members to attend its sessions, without the right to vote or speak, during the time between their election and the date on which their term of office becomes effective; and

Recommends the General Assembly to amend rule 55 of its Rules of Procedure in order to bring its provisions into line with the new rule which this decision entails for the Council's Rules of Procedure.

## Place and date of the second meeting of the Working Party on regionalization

Agenda item 4

The Executive Council,

Recalling General Assembly resolution 26 (II),

Convinced of the need to establish as soon as possible the regional structures required for the proper operation of the Organization,

Requests the Working Party on regionalization to hold its second meeting at Headquarters from 1 to 5 November 1977 immediately before the seventh session of the Executive Council;

Invites the Regional Commissions to examine the report of the Working Party distributed as document A/2/8(e) and to inform it of their comments and recommendations; and

Requests the Chairmen of the Regional Commissions to attend the second meeting of the Working Party on regionalization in order to add their own knowledge of the subject to the comments and recommendations of their respective Commissions.

Draft Convention on the Privileges and Immunities of the World Tourism Organization in the territories of member States

Agenda item 5 (document CE/6/DEC 1 proj.1)

The Executive Council,

Having regard to General Assembly resolution 37(II) concerning the draft Convention on the Privileges and Immunities of the World Tourism Organization in the territories of its member States,

Anxious to have member States take a larger and more active part in preparing the text of the said Convention,

<u>Decides</u> to open the membership of the Council's Legal Working Party to experts of all member States earnestly willing to contribute to its work; and accordingly:

Requests the Secretary-General to communicate this decision to the member States in sufficient time to enable them to state by 30 September 1977 whether they are prepared to take part in the proceedings of the Working Party;

<u>Decides</u> that once the final composition of the Working Party has been established, the Secretary-General shall set the date of its meeting which shall be as soon as possible after 30 September 1977; and

Requests the Legal Working Party to report to the Council and submit to it the revised text of the draft Convention at its eighth session.
