Agenda item 10 **Establishment of UNWTO Regional Offices**

Executive summary

In 2020-2021, several Member States from Africa, the Americas and the Middle East approached the UNWTO Secretariat expressing their interest to host a UNWTO Regional Office.

A Regional Office constitutes an integral part of the Organization in line with the conditions and criteria adopted by the UNWTO General Assembly at its 21st session through resolution 656(XXI).

After a long and productive consultation process with the authorities from the Kingdom of Saudi Arabia, the UNWTO Regional Office building for the Middle East was officially inaugurated in Riyadh on 26 May 2021 on the occasion of the 47th Meeting of the UNWTO Commission for the Middle East.

The Secretariat submits to the General Assembly the detailed information on the background, expressions of interests received, progress made as well as the legal and operational framework for the establishment of the Regional Offices.

Actions to be taken by the General Assembly

DRAFT RESOLUTION1

The General Assembly,

Having examined the report on the Establishment of UNWTO Regional Offices,

- Ratifies the decision of the 112th session of the UNWTO Executive Council CE/DEC/5(CXII) on the endorsement of the proposal of the Kingdom of Saudi Arabia on the establishment of a UNWTO Regional Office in Riyadh;
- 2. Adopts the legal and operational framework for the selection and establishment of Regional/Technical/Thematic Offices;
- 3. Welcomes the proposals of Brazil, Cabo Verde, Ghana, Kenya, Morocco and South Africa to host UNWTO Regional Offices;
- 4. Requests any country interested in hosting a UNWTO Office to provide the necessary legal framework for its correct functioning, in particular by complying with the requirements set forth by resolution 656(XXI);

- 5. Requires that any such expressions of interest be accompanied by an express commitment to provide such legal framework in order to be considered; and
- 6. Requests the Secretary-General to inform periodically on any progress made in the negotiation of host country agreements for the establishment of UNWTO Offices.

- 1. A Regional Office shall carry out functions assigned to it by the General Assembly and the Secretary-General and implement UNWTO's activities in the region in line with the Organization's mandate, key priorities and Programme of Work.
- 2. A Regional Office is an integral part of the Organization. As such, it must comply with the conditions and criteria for Category I entities adopted by resolution 656(XXI)² developed under the model of governance for external entities adopted by the General Assembly through resolution 602(XIX)³.
- 3. A Regional Office shall ensure to effectively conduct relationship with the Organization's Members in a decentralized way based on their needs and priorities as well as ensure strong coordination with international and regional organizations, donor institutions and the private sector stakeholders aiming at rebuilding the tourism sector in the region in a sustainable, responsible and resilient way and fostering socio-economic development of tourism destinations as well as empowering local communities through tourism.
- 4. UNWTO is the smallest UN Specialized Agency of the United Nations system, despite the fact that it serves a sector that is the third largest export-earning category after fuels and chemicals (2019 data). As expressed in the Secretary-General's Management Vision and Priorities, approved by the 108th session of the UNWTO Executive Council, one of the Organization's strategic priorities is to "build better value for Members and expand membership". Following the model of other UN entities, the Organization is engaging and growing towards a fully multilateral dimension, embracing the UN system reforms and deploying its presence at regional level in order to get closer to and better serve the Member States, while showing leadership to future new Members.
- 5. In the United Nations system, the current trend for UN entities/agencies is to have, on average, 5 to 6 Regional Offices in order to better connect their Headquarters with the operations on the ground. The common name of such offices is Regional Office, although other nomenclatures exist, such as: Regional Bureau, Cluster Office, Regional Hub. A comprehensive list of UN Regional Offices is attached to this document as Annex II.
- 6. A Regional Office, being an integral part of the Specialized Agency of the United Nations will serve as a catalyst to further promote universal values and core principles of the United Nations in the corresponding region and to contribute substantially to the advancement of the 17 Goals of the 2030 Sustainable Development Agenda.
- 7. Under the overall supervision of the Secretary-General or designed Senior Officer—as is the practice of the United Nations—in close coordination with the relevant Departments of the Organization's Secretariat, and with the objective of delivering better services to the Member States, a Regional Office may undertake the following activities:
 - (a) Leverage the power and capacity of the UN system at large to support the socioeconomic development of tourism by strengthening cooperation with the UN Resident Coordinators system (United Nations Sustainable Development Group – UNSDG) and UN country teams in the region;
 - (b) Shape strategic partnerships with the development and donor's community to mobilize resources, including regional and international finance institutions;
 - (c) Forge alliance with other development partners, civil society, the private sector, and educational institutions to support the adapted programme of work and activities identified by Member States; and
 - (d) Assist the Secretariat in the process of attracting new Members, both Full and Affiliate from the region to join the UNWTO.

- 8. The Regional Office may undertake the following programmatic activities:
 - (a) Carry out market research on programmatic priority areas as well as prepare thematic studies and guidelines on a regional, sub-regional or national level;
 - (b) Support Member States to develop national tourism intelligence system to better plan and manage their tourism sector;
 - (c) Gather good practices on sector's development from the region;
 - (d) Provide training courses, capacity building programs and workshops for the public and private sector stakeholders from Member States;
 - (e) Facilitate the organization of UNWTO conferences and fora in the region on different areas, namely: sustainability, innovation, education, investments, statistics, etc., including the start-up competitions;
 - (f) Other activities according to specific needs and circumstances of the region.
- 9. The first Regional Office, the UNWTO Regional Support Office for Asia and the Pacific, was established in 1995 in Osaka, Japan, to assist with the development and promotion of tourism in the region. In 2012, the office moved to its current location in Nara, Japan.

II. Legal framework governing Regional Offices of the World Tourism Organization

Host country agreement

10. The establishment of a Regional Office is subject to the conclusion of an agreement with the host State that ensures the appropriate legal framework and, in particular, the principles and conditions for external entities established under Category I as adopted by the General Assembly through resolution 656(XXI). The full list of conditions applying to Category I entities is annexed to the present document.

Status of Regional Offices

- 11. Regional Offices shall be recognized as representing a specialized agency of the United Nations in the territory of the host State. Therefore, the host State must undertake to apply to the Organization at minimum the provisions of the Convention on the Privileges and Immunities of the Specialized Agencies, adopted by the General Assembly of the United Nations on 21 November 1947, and its Annex XVIII, without prejudice to granting additional privileges and immunities for the correct functioning of the Office and to align with those afforded to other offices of the UN in the country or to those enjoyed by the Organization at the Headquarters.
- 12. These are essential, in line with the practice of UNWTO and other organizations of the UN system, to guarantee the independence of the operations of the Organization, the privileges and immunities necessary to its personnel and to the representatives of UNWTO Members. Further, they are necessary to ensure that the legal status and framework of the Organization is respected regardless of the country hosting the office and to prevent any legal or financial liability to the Organization.
- 13. Furthermore, the Organization shall be exempt from all indirect taxes when making important purchases intended for official use, in particular from value added taxes and/or duties which constitute part of the cost of goods purchased by or services rendered to the Organization. In such instances, the host State shall make appropriate arrangements for the remission or reimbursement of the amount of duty or tax.
- 14. As a general principle, the Organization shall enjoy treatment in respect of its privileges, immunities, exemptions and facilities not less favourable than those accorded by the host State to the United Nations and other specialized agencies.

Programme of work

- 15. Insofar as they constitute an integral part of the Organization, Regional Offices shall carry out the mandate assigned to them by the General Assembly under the supervision of the Secretary-General.
- 16. Offices shall be administered from the Organization's Headquarters and be headed by an official appointed by the Secretary-General.

Budget and financial arrangements

- 17. The establishment, organization and maintenance of a Regional Office to carry out its mandate shall be financed by the host State. In particular, the host State's contribution to the functioning of the Office shall cover:
 - (a) The salaries of the Director and officials of the Office and such other personnel as may be assigned to the Office from time to time, including regional allowances and recruitment costs for local employees;
 - (b) Institutional strengthening, modernization and other management issues of the Organization that have an impact on the Office.
- 18. Additionally, the host State shall bear the following costs:
 - (a) Labour, equipment, supplies and other services or property as may be needed.
- 19. The premises of the Office in the location agreed with the host State shall be provided to the Organization free of charge.

Staffing

- 20. The selection, recruitment and contracts of all personnel of the Office shall be subject to the rules and regulations and policies of the Organization.
- 21. Therefore, all Office personnel, including the Head of the Office, shall be recruited by the Organization and be subject to the supervision of the Secretary-General or a designated Senior Officer, as in the practice of the United Nations, and shall not seek or accept instructions from any external authority.
- 22. In addition to officials, the Organization may also hire individuals on a fixed-term contract as service contract holders or experts to support the activities of the Office.

Status of Office personnel

- 23. All officials of the Organization shall enjoy the privileges and immunities provided for under Article VI of the Convention while persons having the status of "experts" shall be accorded such privileges and immunities as are necessary for the independent and effective exercise of their functions and, in particular, those provided for under paragraph 3 of the Annex XVIII.
- 24. For the purpose of enabling them to discharge their functions independently and efficiently, all individuals, irrespective of their nationality or residence, engaged by the Organization to perform services in the execution of the mandate of the Office should be considered by the host State as "officials" within the meaning of Section 18, Article VI, of the Convention⁵. Subsidiarity, when having the status of "experts" they shall be also

- entitled to the privileges and immunities provided for in Sections 19 and 20 of the Convention at a minimum.
- 25. In addition to the privileges and immunities granted to officials, the Head of the Office, and his or her spouse and relatives dependent on him or her, shall be accorded the same privileges, immunities and facilities as are enjoyed by diplomatic agents and their families in the host State.
- 26. All personnel of the Office shall be provided with a personal identity card certifying their status and the privileges and immunities afforded under the host country agreement.

Transit

- 27. All personnel of the Office shall be granted facilities enabling them to enter and leave the duty station and to be repatriated in times of international crisis. To this end, the host State shall issue to all Office personnel promptly, free of charge and without restrictions all necessary visas, permits and authorizations.
- 28. Likewise, the Host Country shall take appropriate measures to facilitate the entry into, sojourn in and departure of all representatives of Members of the Organization and any other persons who, by reason of their functions, must have access to the Office in an official capacity.

Security

- 29. Insofar as the premises of Regional Offices are inviolable, irrespective of their owner, no agent of the host State shall enter them without consent of the Secretary-General.
- 30. The host State shall take all necessary measures to ensure the safety and security of the building and premises of the Office and its personnel in line with the mandatory security standards required by UNDSS.

Meetings

- 31. The Convention and Annex XVIII shall be applicable in respect of meetings and conferences convened by the Organization in the host State. Without prejudice to the provisions of the Convention, all participants and persons performing functions in connection with a meeting or conference of the Organization in the host State shall enjoy such privileges and immunities, facilities and courtesies as are necessary for the independent exercise of their functions in connection thereto.
- 32. Meetings and conferences held outside of the premises of the Office shall require prior notification to the authorities of the host State.

Prevention of abuses

- 33. The privileges and immunities provided to the Organization and the personnel of the Office are only granted with a view to ensuring the effective fulfilment of the Organization's aims and purposes. The Secretary-General shall have the right and the duty to waive the immunity of any member of personnel if it would impede the course of justice and it can be waived without prejudice to the interests of the Organization.
- 34. The Organization and the host State shall cooperate in order to facilitate the proper administration of justice, assure the observance of police regulations and prevent any abuse in connection with the privileges, immunities, exemptions and facilities granted to the Organization and its personnel.

Review of operations

35. The Organization will conduct evaluations as to ascertain whether an Office constitutes a significant contribution to the Organization's aims and objectives and will report periodically on the functioning and operations of Regional Offices to the General Assembly and the Executive Council.

Procedure for the establishment of a Regional Office - steps to follow

- 36. Submission of an official letter of intent (application) of hosting a Regional Office by a Member State to the UNWTO's Secretariat and commitment to all requirements within the host country agreement;
- 37. Dissemination by the UNWTO Secretariat of an application among the Member States of the Region or inclusion the subject at the Regional Commission Meeting for its support and further recommendation.
- 38. Submission by the UNWTO Secretariat of the recommended application to the Executive Council for its endorsement, including any information relevant to the conclusion of the agreement for the hosting of the Office;
- 39. Submission by the UNWTO Secretariat of the endorsed application to the General Assembly for its ratification.

Current development and progress - Information

Africa

- 40. Five Member States, namely Cabo Verde, Ghana, Kenya, Morocco and South Africa expressed their interest to host a UNWTO Regional Office. They have been invited by the UNWTO Secretariat to make respective presentations during the 64th Meeting of the UNWTO Commission for Africa (Sal, Cabo Verde, 3 September 2021).
- 41. The discussion on this topic during the Commission meeting was not conclusive as Member States felt more time is needed for them to reflect on this initiative. In addition, they emphasized the need to receive more information from the Secretariat on the structure, the resources required and the implications of hosting a regional office.
- 42. The Secretary-General received a letter from the Minister of Tourism, Handicrafts and Social and Solidarity Economy of Morocco dated 7 October 2021 reiterating the interest of the Ministry in hosting a UNWTO Regional Office in Morocco and requesting the General Assembly to consider its candidature.
- 43. The Secretary-General received a letter from the Minister of Tourism & Wildlife of Kenya dated 14 October 2021 reiterating the interest of the Ministry in hosting a UNWTO Regional Office in Kenya and requesting that the General Assembly deliberate and adopt clear guidelines for the establishment of Regional Offices before taking a decision on the establishment of Offices in Africa.

The Americas

- 44. On 16 November 2020 the UNWTO Secretary-General received a letter from H.E. Jair Bolsonaro, President of Brazil expressing the interest of Brazil in hosting a UNWTO Regional Office.
- 45. The Secretariat has been regularly consulting the Ministry of Tourism of Brazil on all the necessary procedures and arrangements.
- 46. The Ministry was invited by the UNWTO Secretariat to present the issue at the 66th Meeting of the UNWTO Commission for the Americas (Virtual, 24 June 2021). The Commission members thanked Brazil for the interest shown to continue working and negotiating for the opening of a new UNWTO Regional office in the Americas.

- 47. The Kingdom of Saudi Arabia informed the Secretary-General of its intention to establish a UNWTO Regional Office for the Middle East in Riyadh to strengthen the cooperation and support of the UNWTO for the Middle East Region for a period of fifteen years.
- 48. By its decision CE/DEC/5(CXII), the UNWTO Executive Council endorsed the proposal of the Kingdom of Saudi Arabia on the establishment of a UNWTO Regional Office in Riyadh and requested the Secretary-General to conclude the necessary procedures and signature of the Host Country Agreement for the establishment of the Regional Office and submit a progress report to the next session of the Executive Council.
- 49. The Agreement between the Kingdom of Saudi Arabia and the World Tourism Organization on the establishment of the UNWTO Regional Office for the Middle East in Riyadh was signed in Tbilisi, Georgia, on 17 September 2020 in the context of the 112th session of the Executive Council, in line with the conditions and criteria for external entities adopted by the General Assembly at its 21st session through resolution 656(XXI).
- 50. With the approval by the Council of Ministers on 21 April 2021, the Agreement entered into force as of that date in accordance with its Article 10.2.
- 51. Fully financed by the Kingdom of Saudi Arabia through a voluntary contribution, the UNWTO Regional Office for the Middle East was established in Riyadh as an integral part of the Organization to carry out the functions assigned to it by the General Assembly and the Secretary-General.

Annex I: Conditions applying to Category I entities

- 1. Category I entities are institutionally part of UNWTO and they are established as an integral part of the Organization.
- 2. The establishment of Category I entities is subject to the signature of an agreement with the host Member State that ensures that the appropriate legal framework and juridical personality are provided to the entity and that, at the minimum, includes the conditions herein stated.
- 3. Category I entities are governed by UNWTO's legal framework and by UNWTO Rules and Regulations and are not subject to any national legislation or jurisdiction.
- 4. Category I entities will follow UNWTO accounting policies. Their transactions will be part of UNWTO Financial Statements audited by UNWTO external auditors. They will neither issue their own Financial Statements nor will be audited by other external auditors than those of the UNWTO.
- Category I entities form an integral part of UNWTO's programme of work and budget.
- 6. Wherever located, the Host Country will apply the Convention on the Privileges and Immunities of the Specialized Agencies of 1947 and its Annex XVIII relating to UNWTO to Category I entities.
- 7. Category I entities are directed by a UNWTO employee who reports to and is under the authority of the Secretary-General.
- 8. The selection, recruitment and contracts of Category I entities personnel will follow UNWTO policies, rules and regulations.
- 9. Category I entities are allowed to use UNWTO's name, acronym and logo to indicate that they are an office or centre of UNWTO.
- 10. The government of the host country will take the necessary measures to ensure the safety and security of Category I entities and their premises, considering the mandatory security standards required by the United Nations Department of Safety and Security (UNDSS).
- 11. UNWTO will conduct evaluations of the activities of Category I entities as to ascertain whether they constitute a significant contribution to the UNWTO's objectives and are in conformity with those set out in the agreement with the host country in order to determine either the desirability of extending the agreements beyond the initial duration or their termination.
