CROSSROADS Maldives, which is located in the North Male' Atoll (Kaafu or K. Atoll), is 8 kilometres away from the main international airport, Velana International Airport. It can be reached via speedboat in approximately 15 minutes.

The UNWTO Ministerial Roundtable on Tourism Resilience through Innovation and Digitalization in Asia and the Pacific will be held at the <u>CROSSROADS Maldives</u>, on the afternoon of 14 June 2022, the same resort as the venue for the 34th CAP-CSA Joint Meeting.

Day 2: 15 June 2022

Meeting: UNWTO Global Summit on Community-based Tourism

Venue: CROSSROADS Maldives

The first day of the UNWTO Global Summit on Community-based Tourism, including the Opening Session, will be held at <u>CROSSROADS Maldives</u> in the Republic of Maldives on <u>15 June 2022</u>. It is the same venue as the 34th CAP-CSA Joint Meeting and Ministerial Roundtable meeting on 14 June.

Day 3: 16 June 2022

Event: The 2nd day of the UNWTO Global Summit on 16 June will have three thematic sessions which will be held simultaneously in three different locations as below.

Thematic Session 1: Gastronomy Tourism

Thematic Session 3: Community-based Tourism

The Thematic Session 3 on Community-based Tourism on <u>16 June 2022</u> will be held at the <u>Paradise Island Resort & Spa</u>, the same resort as the venue for the Agro-Tourism Session.

2. REGISTRATION AND BADGES

To participate in these events, prior registration is required. Registration is available through this <u>link</u>. As the capacity for different thematic sessions of the UNWTO Global Summit on Community-based Tourism is limited, we recommend registering as soon as possible. The deadline for the registration is **25 May 2022**.

The badge and information folder will be distributed to the participants on arrival or at the registration desk at the respective meeting venues. The updated information about the registration desks will be available in due course.

3. ENTRY FORMALITIES

Visa Requirements

Tourists visiting the Maldives do not require a pre-approval for a visa. All tourists to the Maldives are granted a free 30-day tourist visa on arrival, provided they have the following documents.

- A passport or a travel document with at least 1 month's validity from the date of expected departure in the Maldives.
- A confirmed hotel booking at a registered tourist facility

COVID-19 Measures

All passengers are required to submit the Traveler Declaration Form within 24 hours to the scheduled flight time, during arrival and departure to and from the Maldives. This health declaration form must be filled in and submitted electronically via the online portal of Maldives Immigration.

Travel-related quarantine is <u>NOT required</u> by any traveller to the Maldives. PCR result is <u>NOT mandatory</u> for any passenger upon arrival and departure. It applies to unvaccinated travelers as well. However, they must check their onward destination's border requirements for PCR and Vaccination requirements. For those participants who require a PCR test for their onward journey, it can be arranged through their respective accommodation facility in the Maldives.

Wearing a face mask is NOT mandatory, however, it is recommended to wear one if you exhibit any symptoms of Covid-19, or if you are in a gathering in confined indoor spaces and whilst using public transportation.

If you develop any COVID-19 symptoms during your stay in the Maldives, you must immediately inform the help desk at your accommodation facility.

General Health Requirements

Travellers are not required to have any vaccinations to enter the Maldives. However, those arriving from yellow fever endemic countries would require to produce a <u>Yellow Fever Vaccination Certificate</u> on arrival at the airport. Customs Regulations

According to Maldivian Law No: 4/1975 (Import prohibition Act), the <u>importation of liquor and alcoholic products without prior approval is prohibited</u>. Hence, it is <u>NOT advised</u> to purchase liquor and alcoholic products on the flight or in duty-free shops while en route to the Maldives, as these items will be confiscated upon arrival at the airport.

List of items which are completely banned for import.

Narcotics and psychotropic substances.

- Pornographic material (including sex toys) such as books, magazines, films, videos, DVDs and software.
- Religious materials offensive to Islam.
- Live pigs.
- Idols (for worship).

List of restricted items which require a specific permit in order to import them.

- Liquor and alcoholic products
- Pork and its by-products
- Chemical and Chemical Products
- Pets
- Firearms/Explosives/Weapons and Ammunition
- Live Plants and Animals
- Medicine
- Tobacco and Tobacco Products
- Communication Equipment

4. HOW TO GET TO MALDIVES

Being one of the first destinations that opened its borders to tourists after the COVID-19 travel restrictions, the Maldives is well connected to the world, receiving flights directly from Europe, Asia, Africa, Middle East and having good connections with the Americas.

5. ACCOMMODATION

With a wide range of tourist facilities available for tourists, from the one-island-one-resort style hotels to live-aboard safari boats to guesthouses and hotels located on the local islands. While the resorts are considered luxury accommodation in the Maldives, with each resort being a private island and only used for the purpose of tourism, guesthouses are located on inhabited islands, providing accommodation mostly to low and mid-market tourists. It is important to note that liquor and pork are not allowed on local islands, hence will not be served in guesthouses. However, they can be available in the resorts.

The recommended accommodation for participants attending all 3 days' events is <u>CROSSROADS Maldives</u>. And for those delegates attending the UNWTO Global Summit <u>only</u>, it is the <u>Paradise Island Resort & Spa</u>. A "Logistics Pack" containing a full list of accommodation options and transfer arrangements for these UNWTO Events in the Maldives will be shared in due course and updated on the <u>website</u>. 6. TRANSFER ARRANGEMENTS AND AIRPORT MEETING SERVICES

Airport pick-up/drop from Velana International Airport (VIA) and the hotel will be arranged by their respective hotels.

The Ministry of Tourism will arrange transfers between the event venues and the accommodation properties listed in **Annex 1.** Details will be updated on the **website** in due course.

For any assistance at the airport, delegates can approach the "<u>Ministry of Tourism Help Desk</u>" at Velana International Airport (VIA), in front of the international arrival terminal as you come out of the terminal.

No airport tax will be charged by anyone arriving in the Maldives directly but will be included in their ticket fare when they purchase it.

Lunch hosted by Ministry of Tourism

On Wednesday, 15 June and Thursday 16 June, the Maldives, Ministry of Tourism will host lunches for the participants of these 3-day events. The lunch on 15 June will be held at CROSSROADS Maldives and the lunch on 16 June will be held at respective venues of the thematic sessions. Exact location of each lunch will be shared in due course.

Farewell Dinner

On Thursday, 16 June at 19:00 hrs, the Farewell Dinner will be hosted by the Government of the Maldives at CROSSROADS Maldives.

Technical Tours

Male' City Tour

A guided tour of Male' City, the capital of the Maldives, was designed especially for the companions of the participants of the 34th CAP-CSA Joint Meeting and the Ministerial Roundtable. More details of this tour will be shared in due course.

8. PRACTICAL INFORMATION

Exchange Rate

The "Maldivian Rufiyaa" (MVR) is the Maldivian Currency. Banknotes are available in denominations of MVR 1000/-, MVR 500/-, MVR 100/-, MVR 50/-, MVR 20/-, MVR 10/-, and 5/-. Coins are available in denominations of MVR 2/-, 1/-, 50 Laari (MVR0.50) and 25 Laari (MVR 0.25).

United State Dollars (USD) are widely used and accepted in Malé City and throughout the Maldives. However, banknotes must be relatively new with no marking or tears. The exchange rate of United States Dollars is 1 USD = MVR 15.42.

Credit Cards

Major credit cards such as AMEX, Visa and MasterCard are widely accepted at resorts, hotels, restaurants and stores. In addition, Automated Teller Machines (ATMs) are available at Velana International Airport (VIA) and in the capital, Male' City and most of the local islands, but not in tourist resorts.

Time Zone

Maldives is 5 hours ahead of Greenwich Mean Time (GMT +5)

Clothing

Participants are advised to bring tropical wear. However, formal attire (Business Suit) is required at official meetings.

Tourists are expected to respect local culture and dress modestly when visiting or staying on local islands. Swimsuits/bikinis are not allowed on the beaches of local islands.

(Note: nudity in any public area or beaches in the Maldives is against the Maldivian Law.)

Official Language

The official language of the Maldives is Dhivehi. However, English is widely spoken and understood. The official language of the UNWTO meetings and events will be English.

Electricity

Electricity in the Maldives runs at 220 - 240 AC (standard flat 3-pin plugs).

Business Hours

Government offices and banks are open from 8:00 am to 2:00 pm from Sunday to Thursday. Banks and Government offices are closed on weekends and Public Holidays. Shops, restaurants and cafes on local islands are generally open from 8:00 am to 11:00 pm. All shops will close for 15 minutes during each prayer time. (Note: Friday and Saturday are the Weekends in the Maldives).

Weather

The Maldives experiences a tropical monsoon climate with year-round warm weather. Temperatures average between 28 °C and 30 °C throughout the year, with the warmest temperatures occurring between March and April. The Northwest monsoon from November to April is mostly dry with very little wind, while the Southwest monsoon from May to October brings some rain and wind. The monsoons in the Maldives are mild. The temperature varies very little, and the humidity rate is high. For more information about the weather in the Maldives, please click here.

Safety and Security

The Government of the Maldives will ensure the safety and security of all participants and delegates with a special focus on safety measures on health guidelines on Covid-19. All necessary precautions will be taken to ensure that the Conferences and Meetings proceed efficiently.

Alcohol Consumption

The state religion of the Maldives is Islam. Therefore, the sale and consumption of alcohol are prohibited. The ban applies not only to the local population but also to tourists. Alcoholic drinks are only available on resort islands.

9. ABOUT THE MALDIVES

The Maldives is an island nation in the Indian Ocean to the southwest of India and Sri Lanka that spans across the equator. The Maldives comprises 1192 islands grouped into a double chain of 26 atolls that stretch along a length of 871 kilometers. Each island is surrounded by white sandy beaches, crystal-clear lagoons, and fenced by coral reefs which are home to a diverse range of colorful marine species. The islands lie just 1.5 meters above sea level. While the country covers an area of approximately 90,000 square kilometers, only 298 square kilometers of that is dry land.

The Maldives has a population of approximately 540 thousand people scattered across the length of the country. More than 30% of the population live in the capital city Male'. Although home to just over half a million people, the Maldives has its own unique culture and traditions.

The Maldivian economy is heavily dependent on the economic benefits of tourism. The tourism industry is the largest contributor to the economy, with over 40% Direct Contribution to GDP, more than 70% Indirect Contribution and 90% Foreign Exchange Earnings.

The Maldives is among the first countries that fully opened its border to tourists after the COVID-19 pandemic. It has been exemplary in its resilience and ability to recover from the pandemic. In 2021, visitor arrivals reached more than 80 percent of pre-COVID levels, far outpacing other similar tourist destinations. With its exemplary approach towards COVID management and destination promotion, the Maldives was crowned, World's Leading Destination Award by the World Travel Awards in 2020 and 2021.
