#### **Executive summary**

The 24th session of the General Assembly (30 November – 3 December 2021, Madrid, Spain) adopted the legal and operational framework for the selection and establishment of Regional/ Thematic Offices and requested the Executive Council to improve it in a timely manner on the basis of the indications provided by the Assembly.

This report presents a revised the legal and operational framework prepared by the Organization's Secretariat upon the request of the General Assembly. The report also informs on the progress made in the negotiation of host country agreements for the establishment of UNWTO Offices as requested by the General Assembly.





#### DRAFT DECISION<sup>1</sup>

## Legal and operational framework for the establishment of UNWTO Regional Offices

(document CE/116/4(b))

The Executive Council.

Having examined the report on the Legal and Operational Framework of the Establishment of UNWTO Regional Offices,

- Takes note with great satisfaction of the improvement of the legal and operational framework prepared by the Organization's Secretariat upon the request of the General Assembly and thanks it for the targeted for the systematic and focused approach proposed;
- 2. Endorses the legal and operational frameworks for the establishment of the UNWTO Regional/Thematic Offices and all the requirements and steps within them; and
- Requests any country interested in hosting a UNWTO Regional or Thematic Office to respect all the established procedures and in particular, to submit a written commitment to comply with the legal and operational framework adopted by the General Assembly and by the Executive Council;
- 4. Requests any Host Country Agreement to comply, at a minimum, with such legal and operational framework; and
- 5. Requests the Secretary-General to report to the Executive Council and to the General Assembly on any progress regarding the establishment of Regional/Thematic offices.

#### I. Background

- 1. The Secretariat submitted to the 24th session of the General Assembly detailed information on the background, expressions of interests received, progress made as well as the proposed legal and operational framework for the establishment of the Regional Offices.
- 2. Through resolution 740 (XXIV), the General Assembly ratified the decision of the 112th session of the UNWTO Executive Council CE/DEC/5(CXII) to endorse the proposal of the Kingdom of Saudi Arabia on the establishment of a UNWTO Regional Office in Riyadh.
- 3. The General Assembly, having examined the report of the Secretary-General, adopted the legal and operational framework for the selection and establishment of Regional/Thematic Offices and requested the Executive Council to improve it in a timely manner based on the indications provided by the Assembly and it welcomed the proposals of Argentina, Brazil, Cabo Verde, Ghana, Kenya, Morocco, and South Africa to host UNWTO Regional Offices.
- 4. The Executive Council, at its 115th session (decision 5 (CXV)) approved, subject to the ratification of the General Assembly, the establishment of the Regional Offices in Brazil, Morocco, and Argentina provided that they are in compliance with the legal and operational framework adopted by the General Assembly
- 5. The Secretariat is submitting to the Executive Council a revised legal and operational framework based on the indications of the General Assembly and informing on the progress made in the negotiation of host country agreements for the establishment of UNWTO Offices as requested by the General Assembly.

## II. Operational framework governing Regional and Thematic Offices of the World Tourism Organization

- 6. Regional and Thematic Offices shall carry out functions assigned to them by the General Assembly and the Secretary-General and implement UNWTO's activities in line with the Organization's mandate, vision and objectives, key priorities, and Programme of Work.
- 7. Regional and Thematic Offices represent an integral part of the Organization. As such, it must comply with the conditions and criteria for Category I entities adopted by resolution 656(XXI)<sup>2</sup> developed under the model of governance for external entities adopted by the General Assembly through resolution 602(XIX)<sup>3</sup>.
- 8. While a Regional Office shall ensure to effectively conduct relationship with the Organization's Members in a decentralized way based on their needs and priorities as well as ensure strong coordination with international and regional organizations, donor institutions and the private sector, a Thematic Office shall purely be focused on the knowledge creation and dissemination in an extensive way, so that the Organization's Members benefit from sound recommendations, guidelines, proposed strategies and business models aiming at sustainable and competitive growth of the tourism sector globally, regionally and nationally. Given the global crisis ongoing pandemic, climate emergency and political unrest, both, Regional and Thematic Offices shall undertake activities to foster the sector's resilience and steady recovery.
- 9. UNWTO is the smallest UN Specialized Agency of the United Nations system, despite the fact that it serves a sector that is the third largest export-earning category after fuels and chemicals (2019 data). The second core objective of the Organization within the Programme of Work 2022-2023 approved by the 24th session of the UNWTO is "Diversification of Services to Members and Expansion of Membership" by which the UNWTO is intending to increase, strengthen and diversify its services to Members in a more tailored way.

- 10. In the United Nations system, the current trend for UN entities/agencies is to have, on average, 5 to 6 Regional Offices to better connect their Headquarters with the operations on the ground. At the same time, there is no standardized approach in the operation of Thematic Offices. A comprehensive list of UN Regional and Thematic Offices is attached to this document as Annex II and III.
- 11. **Common Characteristics of Regional and Thematic Offices are**: 1) Serving UNWTO Members Full, Associate and Affiliate; 2) Functioning at regional and sub-regional levels; and 3) Delivering technical expertise.
- 12. **Key differences between Regional and Thematic Offices are**: 1) Unlike Thematic Offices which may operate on global level, Regional Offices may undertake their actions only on regional and sub-regional levels; 2) Thematic Offices are purely focused on the explicit knowledge creation and dissemination in an extensive way while Regional Offices provide technical expertise in more generic context; 3) Unlike Thematic Offices which conduct targeted research-proven and based activities, Regional Offices contain political component and assist the Organization's Headquarters in ensuring advocacy and outreach by strengthening cooperation with the UN system and other organizations in the respective regions, activating relationships with the donor institutions, partnering with the private sector stakeholders, and attracting new Members, both Full and Affiliate. However, a Regional Office might as well host a Thematic Office for the benefit of better serving the needs of Member States.
- 13. Regional and Thematic Offices, being an integral part of the Specialized Agency of the United Nations will serve as a catalyst to further promote universal values and core principles of the United Nations in the corresponding region and to contribute substantially to the advancement of the 17 Goals of the 2030 Sustainable Development Agenda.
- 14. Under the overall supervision of the Secretary-General or designed Senior Officer—as is the practice of the United Nations—in close coordination with the relevant Departments of the Organization's Secretariat, and with the objective of delivering better services to the Member States, a Regional Office may undertake the following activities:
  - Leverage the power and capacity of the UN system at large to support the socioeconomic development of tourism by strengthening cooperation with the UN Resident Coordinators system (United Nations Sustainable Development Group – UNSDG) and UN country teams in the region;
  - Shape strategic partnerships with the development and donor's community to mobilize resources, including regional and international finance institutions; and
  - Forge alliance with other development partners, civil society, the private sector, and educational institutions to support the adapted programme of work and activities identified by Member States; and Assist the Secretariat in the process of attracting new Members, both Full and Affiliate from the region to join the UNWTO.
- 15. Both, Regional and Thematic Offices may undertake the following programmatic activities:
  - Carry out market research on programmatic priority areas as well as prepare thematic studies and guidelines on a regional, sub-regional or national level;
  - Support Member States to develop national tourism intelligence system to better plan and manage their tourism sector;
  - Gather good practices on sector's development from the region;
  - Provide training courses, capacity building programs and workshops for the public and private sector stakeholders from Member States;
  - Facilitate the organization of UNWTO conferences and fora in the region on different areas, namely: sustainability, innovation, education, investments, statistics, etc., including the start-up competitions; and

- Other activities according to specific needs and circumstances of the region.
- 16. Within the same line of action under the overall supervision of the Secretary-General or designed Senior Officer—as is the practice of the United Nations—in close coordination with the relevant Departments of the Organization's Secretariat, and with the objective of delivering better services to the Organization's Members, a Thematic Office is established to carry out activities and peer research resulting in a sound knowledge creation and dissemination within its field competence.
- 17. In line with the emerging trends and challenges globally, needs of the UNWTO's Members and the key objectives and priorities of the Organization, a Thematic Office might be established on global, regional and sub-regional levels in the fields of sustainability, resilience, safety and security, education, research, culture, innovation, digitalization, investments, entrepreneurship, amongst others.

19. The first Regional Office, the UNWTO Regional Support Office for Asia and the Pacific, was established in 1995 in Osaka, Japan, to assist with the development and promotion of tourism in the region. In 2012, the office moved to its current location in Nara, Japan.

#### III. Legal framework governing Regional/Thematic Offices of the World Tourism Organization

### Host country agreement

20. The establishment of a Regional/Thematic Office is subject to the conclusion of an agreement with the host State that ensures the appropriate legal framework and, in particular, the principles and conditions for external entities established under Category I

as adopted by the General Assembly through resolution 656(XXI). The full list of conditions applying to Category I entities is annexed to the present document.

#### Status of Regional/Thematic Offices

- 21. Regional/Thematic Offices shall be recognized as representing a specialized agency of the United Nations in the territory of the host State. Therefore, the host State must undertake to apply to the Organization at minimum the provisions of the Convention on the Privileges and Immunities of the Specialized Agencies, adopted by the General Assembly of the United Nations on 21 November 1947, and its Annex XVIII, without prejudice to granting additional privileges and immunities for the correct functioning of the Office and to align with those afforded to other offices of the UN in the country or to those enjoyed by the Organization at the Headquarters.
- 22. These are essential, in line with the practice of UNWTO and other organizations of the UN system, to guarantee the independence of the operations of the Organization, the privileges and immunities necessary to its personnel and to the representatives of UNWTO Members. Further, they are necessary to ensure that the legal status and framework of the Organization is respected regardless of the country hosting the office and to prevent any legal or financial liability to the Organization.
- 23. Furthermore, the Organization shall be exempt from all indirect taxes when making important purchases intended for official use, in particular from value added taxes and/or duties which constitute part of the cost of goods purchased by or services rendered to the Organization. In such instances, the host State shall make appropriate arrangements for the remission or reimbursement of the amount of duty or tax.
- 24. As a general principle, the Organization shall enjoy treatment in respect of its privileges, immunities, exemptions and facilities not less favourable than those accorded by the host State to the United Nations and other specialized agencies.

#### Programme of work

- 25. Insofar as they constitute an integral part of the Organization, Regional/Thematic Offices shall carry out the mandate assigned to them by the General Assembly under the supervision of the Secretary-General.
- 26. Offices shall be administered from the Organization's Headquarters and be headed by an official appointed by the Secretary-General.

#### **Budget and financial arrangements**

- 27. Regarding the requirement of the conditions applying to category I entities adopted by the General Assembly, it should be noted that although Regional/thematic offices should be an integral part of UNWTO's budget, this would not be possible unless assessed contributions would be increased to allow for the operation of such offices.
- 28. Therefore, the only possibility at the present moment for the establishment, organization and maintenance of a Regional/Thematic Office to carry out its mandate effectively is that it be financed by the host State through a voluntary contribution. This voluntary contribution is managed by the Secretariat to comply with the program of work approved by the Governing Bodies for the Office and to ensure its correct functioning as well as the necessary support to the Office and coordination extended by the Headquarters of the Organization. Furthermore, the management of the office is subject to UNWTO Financial Regulations and Rules.

In particular, the host State's contribution to the functioning of the Office shall cover:

(a) The salaries of the Director and officials of the Office and such other personnel as may be assigned to the Office from time to time, including regional allowances and recruitment costs for local employees; and

- (b) Institutional strengthening, modernization and other management issues of the Organization that have an impact on the Office.
- 29. Additionally, the host State shall bear the following costs:
  - (a) Labour, equipment, supplies and other services or property as may be needed.
- 30. The premises of the Office in the location agreed with the host State shall be provided to the Organization free of charge.

#### **Staffing**

- 31. The selection, recruitment and contracts of all personnel of the Office shall be subject to the rules and regulations and policies of the Organization.
- 32. Therefore, all Office personnel, including the Head of the Office, shall be recruited by the Organization and be subject to the supervision of the Secretary-General or a designated Senior Officer, as in the practice of the United Nations, and shall not seek or accept instructions from any external authority.
- 33. In addition to officials, the Organization may also hire individuals on a fixed-term contract as service contract holders or experts to support the activities of the Office.

#### Status of Office personnel

- 34. All officials of the Organization shall enjoy the privileges and immunities provided for under Article VI of the Convention while persons having the status of "experts" shall be accorded such privileges and immunities as are necessary for the independent and effective exercise of their functions and, in particular, those provided for under paragraph 3 of the Annex XVIII.
- 35. For the purpose of enabling them to discharge their functions independently and efficiently, all individuals, irrespective of their nationality or residence, engaged by the Organization to perform services in the execution of the mandate of the Office should be considered by the host State as "officials" within the meaning of Section 18, Article VI, of the Convention<sup>5</sup>. Subsidiarity, when having the status of "experts" they shall be also entitled to the privileges and immunities provided for in Sections 19 and 20 of the Convention at a minimum.
- 36. In addition to the privileges and immunities granted to officials, the Head of the Office, and his or her spouse and relatives dependent on him or her, shall be accorded the same privileges, immunities and facilities as are enjoyed by diplomatic agents and their families in the host State.
- 37. All personnel of the Office shall be provided with a personal identity card certifying their status and the privileges and immunities afforded under the host country agreement.

#### **Transit**

38. All personnel of the Office shall be granted facilities enabling them to enter and leave the duty station and to be repatriated in times of international crisis. To this end, the host State shall issue to all Office personnel promptly, free of charge and without restrictions all necessary visas, permits and authorizations.

39. Likewise, the Host Country shall take appropriate measures to facilitate the entry into, sojourn in and departure of all representatives of Members of the Organization and any

other persons who, by reason of their functions, must have access to the Office in an official capacity.

### Security

- 40. Insofar as the premises of Regional/Thematic Offices are inviolable, irrespective of their owner, no agent of the host State shall enter them without consent of the Secretary-General.
- 41. The host State shall take all necessary measures to ensure the safety and security of the building and premises of the Office and its personnel in line with the mandatory security standards required by UNDSS.

#### Meetings

- 42. The Convention and Annex XVIII shall be applicable in respect of meetings and conferences convened by the Organization in the host State. Without prejudice to the provisions of the Convention, all participants and persons performing functions in connection with a meeting or conference of the Organization in the host State shall enjoy such privileges and immunities, facilities and courtesies as are necessary for the independent exercise of their functions in connection thereto.
- 43. Meetings and conferences held outside of the premises of the Office shall require prior notification to the authorities of the host State.

#### Prevention of abuses

- 44. The privileges and immunities provided to the Organization and the personnel of the Office are only granted with a view to ensuring the effective fulfilment of the Organization's aims and purposes. The Secretary-General shall have the right and the duty to waive the immunity of any member of personnel if it would impede the course of justice and it can be waived without prejudice to the interests of the Organization.
- 45. The Organization and the host State shall cooperate in order to facilitate the proper administration of justice, assure the observance of police regulations and prevent any abuse in connection with the privileges, immunities, exemptions and facilities granted to the Organization and its personnel.

#### **Review of operations**

46. The Organization will conduct evaluations as to ascertain whether an Office constitutes a significant contribution to the Organization's aims and objectives and will report periodically on the functioning and operations of Regional Offices to the General Assembly and the Executive Council.

#### Procedure for the establishment of Regional and Thematic Offices - steps to follow

- 47. Submission of an official letter of intent (application) of hosting a Regional/Thematic Office by a Member State to the UNWTO's Secretariat and commitment to all requirements within the host country agreement;
- 48. For a Thematic Office only: Submission by the UNWTO Secretariat the application received from a member State (strictly responding to the key thematic approved in the Programme of Work by the General Assembly of the same biennial period) for the review and further recommendation of the Programme and Budget Committee, a subsidiary body of the Organization's Executive Council Unlike a Regional Office, the application for the establishment of a Thematic Office is not a subject to the inclusion in the agendas of the respective Regional Commission meetings.
- 49. Dissemination by the UNWTO Secretariat of an application among the Member States of the Region or inclusion the subject at the Regional Commission Meeting for its support and further recommendation.

- 50. Submission by the UNWTO Secretariat of the recommended application to the Executive Council for its endorsement, including any information relevant to the conclusion of the agreement for the hosting of the Office.
- 51. Submission by the UNWTO Secretariat of the endorsed application to the General Assembly for its ratification.

#### **Current development and progress – Information**

- 52. Pursuant to the Executive Council decision to approve, subject to the ratification of the General Assembly, the establishment of the Regional Offices in Brazil, Morocco, and Argentina provided that they are in compliance with the legal and operational framework adopted by the General Assembly, the Secretariat has been in contact with Brazil, Morocco and Argentina to discuss the legal and operational framework adopted by the General Assembly.
- 53. Negotiations with Brazil on the conclusion of a host country agreement are very advanced but have not yet concluded. After the General Assembly, the host country agreement template was shared with Argentina and Morocco, but no progress has been made. To date, only Argentina has submitted the express commitment to provide the necessary legal framework, in particular by complying with the requirements set forth by resolution 656(XXI), which is required by the General Assembly in order for a candidature to be considered.
- 54. The Secretariat has also been in contact with the Government of Japan to improve the legal and operational framework of UNWTO Regional Office, the UNWTO Regional Support Office for Asia and the Pacific (RSOAP), which was established in 1995 in Osaka, Japan, through General Assembly resolution 305 (X), to assist with the development and promotion of tourism in the region. In 2012, the Office moved to its current location in Nara, Japan. In 2017, the Regional Support Office set up a liaison office in Tokyo at the United Nations University.
- 55. Ever since Japan undertook to apply to UNWTO the provisions of the Convention on the Privileges and Immunities of the Specialized Agencies in 2020, the Secretariat has furthered efforts in cooperation with the Japanese Government to reform the Regional Support Office in accordance with the conditions applying to Category I entities adopted through the General Assembly resolution 656 (XXI), in particular through the conclusion of a host country agreement for the functioning of the Regional Support Office in Japan.

\* \* \*

- 1. Category I entities are institutionally part of UNWTO and they are established as an integral part of the Organization.
- 2. The establishment of Category I entities is subject to the signature of an agreement with the host Member State that ensures that the appropriate legal framework and juridical personality are provided to the entity and that, at the minimum, includes the conditions herein stated.
- 3. Category I entities are governed by UNWTO's legal framework and by UNWTO Rules and Regulations and are not subject to any national legislation or jurisdiction.
- 4. Category I entities will follow UNWTO accounting policies. Their transactions will be part of UNWTO Financial Statements audited by UNWTO external auditors. They will neither issue their own Financial Statements nor will be audited by other external auditors than those of the UNWTO.
- 5. Category I entities form an integral part of UNWTO's programme of work and budget.
- 6. Wherever located, the Host Country will apply the Convention on the Privileges and Immunities of the Specialized Agencies of 1947 and its Annex XVIII relating to UNWTO to Category I entities.
- 7. Category I entities are directed by a UNWTO employee who reports to and is under the authority of the Secretary-General.
- 8. The selection, recruitment and contracts of Category I entities personnel will follow UNWTO policies, rules and regulations.
- 9. Category I entities are allowed to use UNWTO's name, acronym and logo to indicate that they are an office or centre of UNWTO.
- 10. The government of the host country will take the necessary measures to ensure the safety and security of Category I entities and their premises, considering the mandatory security standards required by the United Nations Department of Safety and Security (UNDSS).
- 11. UNWTO will conduct evaluations of the activities of Category I entities as to ascertain whether they constitute a significant contribution to the UNWTO's objectives and are in conformity with those set out in the agreement with the host country in order to determine either the desirability of extending the agreements beyond the initial duration or their termination.
