# UNWTO Conference on the International Code for the Protection of Tourists HIGH-LEVEL DISCUSSION



### Dr. Sok Siphana Senior Advisor of the Royal Government of Cambodia

Dr. Sok Siphana is a practicing attorney at the law firm of SokSiphana&associates.

He was appointed by Prime Minister Samdech Techo Hun Sen as Senior Advisor to the Royal Government of Cambodia in September 2018 with the rank of Senior Minister.

He is currently the Chairman of the Board of the Asian Vision Institute (AVI) a think tank which he cofounded in 2018. Previously from 1999 to 2005, he served as Secretary of State at the Ministry of Commerce, where he acted as the lead negotiator in Cambodia's accession to the WTO.

From October 2005 to July 2009, he served as Director at the International Trade Center (ITC), a joint technical agency of UNCTAD and the WTO in Geneva, Switzerland.

Dr. Sok is a holder of a Juris Doctor (J.D.) from Widener University School of Law in Delaware, United States (1992); a Doctor of Philosophy (Ph.D.) from Bond University School of Law in Queensland, Australia (2009); and a Docteur en Droit with the Université de Paris II Panthéon-Assas, France (2022).



#### H.E. Dr. Thong Khon Minister of Tourism, Cambodia

Dr. Thong Khon, assumes his position as Minister of Tourism of the Royal Government of Cambodia for a second term from September of 2013 after having led the Ministry of Tourism for a full term from 2007. Prior to his well-deserved promotion, the Minister had served at the Ministry of Tourism as a Secretary of State since 1993.

Dr. Thong Khon began his services in public office actively participating in leading, restoring and developing the Capital City of Phnom Penh. He had spent 3 years at the Ministry of Culture and Fine Arts (1990-1993), leading it to grow and excel the nation's rich cultural abundance for tourism potentials. The Minister's participation in leading and administering the tourism sector for the Kingdom of Cambodia spanned more than 25 years to date and he is extremely dedicated in leading Cambodia tourism to continue being the priority sector for contributing to the country's national economic development. He was Chief of Personnel Bureau of the Phnom Penh Municipality in 1979; became Vice Mayor of the Phnom Penh Municipality in 1983 and subsequently promoted and served as Mayor from 1985 until 1990.

Over the years. Dr. Thong Khon has been awarded a respectable number of awards and decorations by various governments and organizations for his distinguished contributions in different aspects of public service. Locally, he was awarded a Cheatopaka Medal by Prime Minister Hun Sen of the Kingdom of Cambodia in 2009. Globally, the Minister was decorated with a Gwanghwa Medal by the late Roh Moo Hyun, Former President of the Republic of Korea and was twice presented a World Leadership Award during the World Ecotourism Conference; once in 2008 and again in 2011.

Minister Thong Khon earned a Diploma of Doctor of Medicine from the University of Phnom Penh in 1995. a Postgraduate Diploma in Public Health and Community from University of Nancy, France in 1997 and conferred a Phd degree in Tourism Management (Ecotourism) from the National University of Economics in Hanoi. Vietnam, 2011. In April 2014, he was awarded an Honorary Degree of Doctor by the University of Sunshine Coast in Queensland, Australia, recognizing his distinguished service in developing community-based ecotourism and the pro-poor tourism in Cambodia.

H.E. Dr. Thong Khon is one of the longest serving ministers of tourism in the world. The Minister was especially praised by the President of European Council on Tourism and Trade (ECTT), Professor Dr. Anton Caragea, for his vision and astute policies and devotion to the development of Cambodia when he was appointed a member of the European Tourism Academy.



### H.E. Dr. Sandiaga Salahuddin Uno Minister of Tourism and Creative Economy, Indonesia

Sandiaga Salahuddin Uno or better known as Sandiaga Uno, was inaugurated by President Joko Widodo as Minister of Tourism and Creative Economy/Head of Tourism and Creative Economy Agency on December 23, 2020.

Sandiaga Uno earned an academic degree in Bachelor of Business Administration from The Wichita State University, United States, and graduated with Summa Cum Laude predicate. Furthermore, he obtained a Master of Business Administration from The George Washington University, United States. Sandiaga Uno is a renowned businessman with various experiences serving as directors of a number of companies in various sectors, including: Summa Group, Jakarta, May 1990 – June 1993; Seapower Asia Investment Limited, Singapore, July 1993 – April 1994; MP Holding Limited Group, Singapore, May 1994 – August 1995; NTI Resources Limited, Calgary, Canada, September 1995 – April 1998; PT Recapital 1997 - 2007; PT Saratoga Investama Sedaya, April 1998 – June 2015.

His political career began when he was sworn in as Deputy Governor of DKI Jakarta for the 2017-2022 period. During this period, he intensively created programs aimed at fostering entrepreneurship in Jakarta residents. He was also actively encouraging DKI Jakarta to become a halal tourist destination.

In the beginning of his leadership at the Ministry of Tourism and Creative Economy/Tourism and Creative Economy Agency, Sandiaga Uno carried the concepts of innovation, adaptation, and collaboration. Innovation is needed because in a brief time there must be a fundamental change in revamping the tourism and creative economy sector. Adaptation is required considering that Indonesia is dealing with the Covid-19 pandemic so that the tourism and creative economy industry need to implement adaptations of new habit or also known as Cleanliness, Health, Safety and Environmental Sustainability (CHSE). Meanwhile, collaboration is necessary because to recover the tourism and creative economy sector requires the involvement of all parties.



### H.E. Ms. Maria Esperanza Christina Garcia Frasco, Secretary, Department of Tourism, Philippines

**Secretary Ma. Esperanza Christina Garcia Frasco** is the current Secretary of the Department of Tourism. A multi-awarded Mayor of the Municipality of Liloan in the Province of Cebu, her transformational leadership fostered Liloan's development towards sustainability, livability, and innovation with aggressive infrastructure development, education support, economic recovery, and social protection programs earning awards for Liloan as the Top Model Municipality and Most Resilient Municipality in the Philippines.

Throughout the challenges of the pandemic and the super typhoon that recently devastated Central Visayas, she led Liloan's recovery and resurgence towards having the highest growth rate in Cebu. Under her leadership, Liloan has the distinction of being a four-time recipient of the highest audit rating given by the Commission on Audit, and it has received more than 40 good governance awards and citations from local and national award-giving bodies.

In 2021, she was awarded the Presidential Lingkod Bayan Regional Award by the Civil Service Commission, and she was ranked the Top Performing Mayor in Central Visayas, ranking number 1 among all Municipal Mayors in the entire Region 7. She was the first woman President of the League of Municipalities of the Philippines Cebu, and the National Vice President of the League of Municipalities.

A lawyer by profession, she practiced international arbitration and commercial litigation and was a professor of law prior to joining public service in 2016. For her vast experience in local governance, Vice President Sara Z. Duterte appointed then Mayor Frasco her spokesperson for the 2022 National Elections.

After winning a fresh mandate for her third and final term as Mayor in the last elections, President Ferdinand R Marcos, Jr. handpicked her to lead the Department of Tourism (DOT), a challenge she whole-heartedly accepted as she committed to support the President's vision for tourism to become one of



### H.E. Dr. Abdulla Mausoom Minister of Tourism, Maldives
