## Addendum 1

1. The purpose of this addendum is to update the information contained in document $\mathrm{A} / 16 / 23$.

## I. MEMBERSHIP OF THE COUNCIL

2. Since the date of the main document, one State, namely the United Kingdom of Great Britain and Northern Ireland has confirmed its intention to join the Organization effective 25 November 2005.
3. The four States that have confirmed their desire to join the Organization are therefore the following:

5. Papua New Guinea
6. Timor-Leste
7. United Kingdom
8. At the date of the General Assembly, the number of Full Members will be 150, taking into account the admission of the Bahamas and of the United Kingdom effective 25 November 2005, and the candidatures of Papua New Guinea and Timor-Leste pending ratification by the General Assembly. As a result, the Council will be composed of 30 Members during the period between the sixteenth and the seventeenth sessions of the General Assembly, that is, two more than the outgoing Council, in addition to Spain as a Permanent Member.
9. To arrive at the total of 30 seats, three so-called "floating" seats remain to be assigned to one of the regions that have a remainder over the exact fractions of five Members, viz.:
